Venue

Searching for larger space; needs include accessibility, noise control, supervision, low cost

Operations

Incorporation as a society

Review partnerships with ACA, CCC

Fund-raising (eg. casino)

Volunteers opportunities for all parents, different roles

Differentiate players based on skills, support different groups of players

Review of Constitution and Bylaws (Ved)

Ved explained that the reason to change the bylaws is to meet the government requirement as a non-profit organization

(Changes require motions with 75% approval as per By-laws)

- I move that the new name of club shall be "Calgary Junior Chess Club (CJCC)", from "Calgary Junior Chess Club"

- I move that the tournament director fee be raised to \$20 from \$10.
 - Moved by Chandra, seconded by Ved, voted in favour
- I move that we should make changes to the Bylaws as required by government registration.
 - Moved by Ved, seconded by Kevin, voted in favour
- I move that the Bylaws be amended such that 2 auditors (who did not have signing authority in the previous year) shall be elected at the AGM for the purpose to review the accounts of the previous year. If none are elected, the Board may appoint two people.

- I move that two auditors from ouside of the Board shall be elected to review the accounts for the coming year
 - Moved by Ved, seconded by (not recorded), voted against
